#### **Regular Business**

The Board of Education approved the agenda as presented.

- Authorized the Superintendent to execute the agreement with Michigan Department of Health and Human Services for the Mi-APPP program for \$239,152 for the term October 1, 2017 through September 30, 2018, as presented.
- Authorized the Superintendent to execute the agreement with MSHN for \$607,230 for the term of October 1, 2017 through September 30, 2018, as presented.
- Authorized the Superintendent to execute the service agreement with Lansing School District for the Taking Pride in Prevention Grant in the amount of \$37,880 for the term of October 1, 2017 through September 30, 2018, as presented.
- Authorized the Superintendent to execute the service agreement with Michigan Primary Care Association in the amount of \$80,000 for the term of October 1, 2017 through September 30, 2018, as presented.
- Waived the second reading of board policies #1111 and #3131 regarding teacher/administrator reduction and recall and approved as presented.
- Adopted the Board of Education Governance Standards published by the Michigan Association of School Boards and commit the Eaton RESA Board of Education and its individual members to conducting itself in a manner consistent with these Governance Standards.
