January 17, 2024

Regular Business

- The Superintendent and cabinet members recognized the Eaton RESA Board of Education members for their service to the District in celebration of January as School Board Recognition Month.
- Dr. Sarah Parker and Paige Rife, Directors of Meadowview Programs, as well as some Meadowview staff, shared updates and highlights about the Meadowview School program.

In other action, the Board:

- Approved the travel request for Kim Thalison and two prevention specialists to attend CADCA's 34th
 Annual National Leadership Forum in National Harbor, Maryland, January 28-February 1, 2024. Costs are covered by grant funds and a scholarship through Mid-State Health Network.
- Waived the second reading and approved the following NEOLA policy update covering the following as presented.
 - a. New Policies #1540 and #3132
 - b. Revised Policies #0122, #1420, #2370.01, #3131, #3142, #3220, #7217, #7540.03, and #8531
 - c. Technical Correction #8305
 - d. Reissued Policies #3120 and #3139
 - e. Reviewed Policies #3130 and #3140
- Considered and adopted a resolution to declare the dissolution of Oneida Township School District #3 and the subsequent transfer of its territories and property to Potterville Public Schools, as presented.



- Authorized the Superintendent to execute a subcontract agreement with Grand Ledge Public Schools (GLPS) in an amount not to exceed \$170,000 for infrastructure and construction expenses related to the school-based health clinic located at GLHS from October 1, 2023, through September 30, 2024, as presented.
- Authorized the Superintendent to execute an agreement with CompHealth Medical Staffing in an amount not to exceed \$51,504 to provide contracted occupational therapy services for a staff maternity leave of absence from January 22, 2024, through May 10, 2024, as presented.

- Tina Monroe shared updates to the 10-year capital projects plan, along with identified projects for 2023-24 and 2024-25. The plan was developed as a tool to address building improvement needs and provide a schedule so upgrades are completed in a timely manner. The plan also assists in the financial planning of how projects are to be funded.
- As the initial component of the Board's process for conducting an annual performance evaluation of the District's Superintendent, Sean Williams will provide the Board with his self-assessment, a summary of accomplishments/evidence and student growth data.
