I. Organizational Meeting

Regular Business

The Board of Education approved the agenda as presented.

Cindy Anderson, Superintendent provided an overview of the 2017-18 Eaton RESA Annual Report to the Board of Education.

Cindy Anderson, Superintendent introduced Kathleen Szuminski, who was recently hired as the new Assistant Superintendent for Career and Technical Education to the Board of Education.
