

Why this guide?

Once districts have established their <u>Sex Education Advisory Board</u> (SEAB) membership and by-laws, it may be time to decide on a sexual health education curriculum. Michigan law states that one task of the SEAB is "Reviewing and recommending materials and methods to the local school board."



There are many resources that can aid SEABs in selecting curriculum such as the **Health Education Curriculum Analysis tool (HECAT)**, a self-assessment tool that can be used in the health education curriculum selection process.

Reviewing district, state, and national data can also aid SEABs in the curriculum selection process. Data like the <u>Michigan Profile for Healthy</u> <u>Youth</u> (MiPHY) or the <u>Youth Risk Behavior Surveillance Survey</u> (YRBSS) can assist SEABs in understanding what behaviors may need to be focused on in the curriculum. A parent survey is another valuable piece of data for SEABs. A <u>sample parent survey</u> can be found in the Exemplary Sexual Health Education (ESHE) Guide from the Michigan Department of Education.

This guide is designed to be another resource to aid SEABs in their decision making by outlining the curriculum content for a variety of sex ed curricula. Curricula are large documents and can be cumbersome to review. This guide contains curriculum snapshots, which give SEABs a quick, easy-to-read overview of some sexual health education curricula. This guide does not include an extensive review

of all sexual health curricula. The curricula that were chosen for this guide were: Michigan developed,

used by numerous Michigan districts, aligned with Michigan law, and/or low cost or no cost. The information on the snapshots is designed to help SEABs consider whether

they want to include or eliminate a curriculum in their more comprehensive curriculum review process.

On the snapshots, districts will find basic information such as the intended grade levels, the number and length of the lessons, and the cost of the curriculum. The snapshots offer insights into whether the curriculum encompasses specific subjects, including those mandated by legal requirements such as topics falling under the A-K requirements and the emphasis on abstinence as well as topics that SEABs may be interested in

adding as supplemental education. The curriculum snapshots address if the curriculum is abstinence only or not. In Michigan, sexual health education must be abstinence based, emphasizing abstinence. School districts may also teach about risk reduction methods such as condoms. Additionally, sex education, if taught in Michigan, must cover the <u>A-K Criteria</u>. Especially for curricula developed outside of Michigan, it may be necessary to make some changes to curricula and to include supplemental lessons or

materials to comply with Michigan law. The curriculum snapshots include an A-K correlation from the curriculum publishers, and some include suggestions for supplemental materials that would be beneficial to meet A-K requirements. An <u>A-K Gap Analysis</u> worksheet may be helpful to utilize when reviewing curricula that originated outside of Michigan. Districts may also use the <u>Supplemental A-K</u> <u>Resource Sheet</u> to look for supplemental materials. <u>See a summary of</u> <u>Michigan HIV and Sex Education laws here</u>.

The <u>Sexuality Education for People with Developmental Disabilities</u> training, also known as *Elevatus*, has two parts: an instructor manual and 22 scripted lessons. The manual is designed to give educators confidence in teaching sexuality education in the classroom or in a community setting. The manual provides support on setting up a class, how to lead a successful sexuality and relationship classes and more important tips. The curriculum was designed to be co-facilitated by people with developmental disabilities and professionals. This design allows people with developmental disabilities to be sexual educators and sexual health self-advocates for themselves. The lessons are 1.5 hours long, include ice breakers, activities, a break, and a wrap up activity. The script for the lessons are in blue and intended to be used as a guide. Handouts and teacher tools are available at the end of lessons. Digital handouts are available by request. The lessons are also available in Spanish.



Special Education FLASH offers a broad range of activities and suggested modifications to fit different learning styles and cognitive abilities. Within the lessons, the left-hand column has activity variations, and there is a section on how to incorporate FLASH into an IEP. The goal of Special Ed FLASH is to assist in the development of persons who are knowledgeable about human development and reproduction, and who respect and appreciate themselves, their families and others. Topics of discussion include relationships, communication skills, exploitation, understanding the body, reproduction, and HIV/AIDS and other STDs.

Middle School *FLASH* is an evidence-informed comprehensive sex education curriculum. *FLASH* employs a public health approach with the goals of reducing the rates of unintended pregnancy, STIs, and sexual violence. It was piloted extensively with classroom teachers in its 2016 update. Each lesson has an optional family homework exercise to encourage parent or guardian communication with the teen. The curriculum offers optional scripting for teachers who are new to the content. The middle school lessons cover the reproductive system and pregnancy, sexual orientation and gender identity, healthy relationships, refusal skills, STIs prevention, birth control and condoms.



High School *FLASH* is an evidence-based comprehensive sex education curriculum. It was rigorously evaluated by an independent research team with funding from the U.S. Department of Health and Human Services.

FLASH employs a public health approach with the goals of reducing the rates of unintended pregnancy, STIs, and the perpetration of sexual violence. Each lesson has an optional family homework exercise to encourage parent or guardian communication with the teen. The curriculum offers optional scripting for teachers who are new to the content. Lesson content covers climate-setting, reproductive system and pregnancy, sexual orientation and gender identity, gender stereotypes, healthy relationships, coercion and consent, online safety, abstinence, birth control methods, condoms, preventing and testing for STIs, communication and decision making, and advocating for healthy choices.

Get Real is an evidence-based middle school curriculum developed by Planned Parenthood League of Massachusetts and published by ETR that meets the National Sexuality Education Standards. There are 27 sequential lessons in middle school and 11 lessons for high school. The high school Get Real curriculum can be taught as a stand-alone curriculum but is intended to be utilized as a follow-up to the Get Real middle school curriculum. 





Growing up and Staying Healthy is a skills-based HIV Prevention/Sexual Health Education module of the Michigan Model for Health comprehensive health education curriculum. The curriculum can be taught as Abstinence Only or as Abstinence Based. If teaching the curriculum as an Abstinence Based curriculum, a lesson (#8) on condoms use and the steps to condom use is included. The lesson, as written, does not include a teacher-led condom demonstration.

The curriculum was developed and written in Michigan; thus, it adheres to Michigan sexual health education requirements like the A-K list and addresses the Michigan Health Education Standards. A pre and post test is available for use with the curriculum.




Healthy and Responsible Relationships: HIV, Other STIs, and Pregnancy Prevention is a skills-based HIV Prevention/Sexual Health Education module of the Michigan Model for Health comprehensive health education curriculum. The curriculum can be taught as Abstinence Only or as Abstinence Based with condoms, or Abstinence Based with condoms and contraception. If taught as an Abstinence Based, districts can opt to include the lessons on condom use, which includes a teacher-led skill demonstration with the option for students to practice the skill. The Abstinence Based version of the curriculum also includes lessons on contraception options.



Rights, Respect, Responsibility has a Michigan adapted scope and seaquence to meet the requirements of Michigan standards. The Michigan lessons start at grade 4 and go through grade 12. 

Safer Choices has two levels of lessons designed to be taught over two years in high school using interactive teaching methods such as pre and post tests, role-plays, games, small-group activities, and guided discussions. The curriculum consists of STD, HIV, and teen pregnancy prevention. The goal of *Safer Choices* is to reduce the number of high school students engaging in unprotected sexual intercourse by delaying sex in high school or using protective measures such as condoms if students are sexually active. Behavioral change is encouraged with skills to develop self-efficacy, refusal and negotiation skills, functional knowledge, social and media influences, peer norms, and parent/child communication. Students should have a basic understanding of reproductive anatomy and physiology before completing *Safer Choices*. The lessons are designed to be sequential and are 45-minutes long but can be adapted as needed. Student workbooks are required for implementation of the lessons. The curriculum utilizes 5 to 8 elected students from each class to serve as peer leaders.
